


**Minutes of the Meeting of the members of the 5<sup>th</sup> State Finance Commission under the Chairmanship of the Chairman, 5<sup>th</sup> State Finance Commission at 11.30 A.M. on July 23<sup>rd</sup>, 2024 (Tuesday) in the chamber of the Chairman of the Commission (Room No. 141, Yojna Bhawan)**


1. Today, July 23, 2024 (Tuesday), a meeting of the members of the 5<sup>th</sup> State Finance Commission was held under the chairmanship of the Chairman, 5<sup>th</sup> State Finance Commission in the chamber of the Chairman of the Commission (Room No. 141, Yojna Bhawan).
2. The meeting was attended by the members of the commission, Sri Harishwar Dayal and Ms. Nisha Oraon.
3. The issues related to the functioning of the Panchayats and the implementation of the Gram Panchayat Development Programme (GPDP) were discussed in this meeting.
4. Ms. Nisha Oraon, the Director of Panchayati Raj and member of Fifth State Finance Commission, informed that the Department of Panchayati Raj has assigned the task to conduct an integrated and planned evaluation of Zila Parishad, Panchayat Samiti and Gram Panchayats to IIM Ranchi. The study which is being conducted in a sample of 50 Gram Panchayats, 10 Panchayat Samitis and 5 Zila Parishads is in progress.
5. The study of the implementation of the GPDP has also been assigned by the department of Panchayati Raj to six reputed organizations of the state namely Kalamandir, Jamshedpur, Tata Steel Foundation, East Singhbhum, PRADAN, TRI, Ranchi, AFC India Ltd and PHIA Foundation.
6. The department has also requested a few reputed instituticuns of the country (IRMA, TISS, XLRI, XIMB and IIM, Ranchi) to conduct studies on
  - a. The Revenues of the PRI
  - b. Expenditure pattern of the PRIs
  - c. Impact of mining activities
  - d. Use of IT in the working of PRIs
  - e. Progress of implementation of e-Panchayat / e-Gram Swaraj
  - f. The expectation of the PRI from the present (5<sup>th</sup>) SFC
  - g. Status of delegation of power to the PRIs
  - h. Success Stories of PRI
  - i. Evaluation/ grading of the district/ block/RLBs.
