**Sub: Your Deptt's. efforts to provide Drinking water, SLWM, implementation of waste rules and involvement of the PRI & ULB.**

Sir,

As you are aware that after launch of Swachha Bharat Mission (SBM) on 02-10-2014 it was decided that DWSD and UD&HD will implement the household and community SBM activities in Rural and Urban areas respectively. The concerned other departments will address the similar issues in the offices/establishments falling under the administrative control of the concern department.

In view of above it is pertinent that schools, residential schools, Hospital/PHC/APHC, ICDS center, Panchayat Bhawan, Gram Kachahri, Halka Kachahri Hostel and residential schools, day centre etc will be covered by the respective administrative department. This must have been done and regular updation and upkeep must be taken care by the department.

This is also relevant to note that these activities are very important in SDG as well. 15<sup>th</sup> FC is also giving resources to ULB/RLB for the similar activities. In the field visit of 5<sup>th</sup> SFC this comes to notice that no mechanism exist to know the allocation of the department by ULB/RLB and there is no mechanism of close interaction among the department and local bodies. This may lead the duplication of the resources as many places PRI is spending the resources for schools/ICDS etc.


GPDP is one forum where all the departments need to interact with annual scheme selection at GP level. The activities of GPDP need to be attended by the deptt. regularly. This may help preparation of holistic GP level action plan. This will help to all stake holders in suitable resource mapping too. The resources can be allocated in the next year budget for the activities related to concerned deptt. For any clarification concern deptt. may interact deptt. Panchayati Raj, GoJ and DC/DDC of respective districts. A letter of Deptt. of Panchayati Raj was issued for the GPDP of 2024-25 vide letter no; 2284 dt. 26.09.2024. The activities can be included in the Budget of FY 2025-26 of the concern Deptt.


